Selectmen,

My name is Mike Rowinsky and I am a resident of Middlebury, CT and have lived here for the past two years. I'm currently employed at Westover School as a biology teacher. I am sending this before you to respectfully request permission to hunt the approximate 138 acres of town property indicated by the attached map for the 2015-156 hunting season for whitetail deer and turkey using archery, shotgun, and rifle during the season dates set by the CT DEEP.

I have been safely hunting since I was nine years old; I'm a combat veteran having served in the United States Navy as a gunner's mate and combat craft operator during Desert Shield/Storm. I've been happily married for thirteen years and am the proud father of three kids.

If I'm granted permission to hunt this piece of property:

- I will obey all hunting laws and regulations established by the CT DEEP.
- I will not damage fences, gates, buildings, or other property.
- I will not litter or dump any rubbish.
- I will not attach any permanent structures to trees, and will remove any temporary stands no later than one week after the close of the season.
- I will utilize a hand-held GPS system to make certain I am well within the boundaries of the property I'm granted permission to hunt on.
- I will respect the rights of the property owner.

I recognize that this permission is only valid on the lands of the issuing landowner (Town of Middlebury, CT) and for the specific seasons specified above. I will reapply for permission for future seasons separately from this initial application. NO agreement is made regarding future permissions.

I appreciate your time and consideration on this matter and am more than willing to offer further documentation if you feel it necessary.
