He is hoping this will amount to something because they spend over \$200,000.00 a year on electricity. He said it is a complex solar proposal with no obligation to the town. They will have to put it out to bid once it's decided and completed. Ed St John said the solar panels might offset what the town spends on electricity. He said the biggest users are the sewer pump stations, the police department and the fire department buildings.
