Ed St John is happy with the activities that they are able to provide patrons. He feels things are going excellent and was very supportive. JoAnn handed the trustees a copy of the new sign. She reviewed the October 2021 calendar of events and programs being

offered. JoAnn said that the Book Explorer book club meets monthly on Zoom, they are offering an adult brown bag book discussion, there is a scarecrow judging contest and there will be a teen costume party for grades 6 through 12. She said they are continually getting creative, especially with the children's area. She said they offer a scavenger hunt on Saturdays for ages 3 through 7. JoAnn said the story walks and the tailgate story time was well attended. She said she is continuously checking the updates on the Covid-19 tracker. JoAnn said the memorial for Mary Engelman children's books on display has used about \$800 out of the \$2000 in purchasing so far. She said that every book has her name in memory of.

JoAnn handed the trustees the holiday schedule for 2021-2022, and noted there were no conflicts for their meetings.

Pat asked how the kids were doing with the Zoom sessions. JoAnn said they are embracing it and adapting well.

# Middlebury Public Library Code of Conduct Policy Revised Covid-19 Addendum

- Patrons with a temperature or feeling sick should not come to the library.
- Patrons must use hand sanitizer as they enter the library.
