

Small Quassy field

Smash Factory – Sundays

PYB – The rest of the week

Fall Season: Both Smash and PYB will talk after the registrations are in.

PYB is interested in using Shepardson this year for T-Ball.

It should be noted that both organizations will share their schedules and will work together on the unused days they might have. Michael Roach will monitor the used of the fields during the season. They both also understand that Quassy Amusement park has first right of refusal if they need the fields for parking or an event.

Both teams are responsible for the raking and lining the field before the games. They will also clean up after each game. When bathrooms and garbage get filled Smash Factory will notify PYB Baseball. The locked box and combination will remain with PYB. Smash Factory was acquiring if they can use a portion of the shed on town property to store some of their equipment to maintain the fields.
