Reappointments

First Selectman St. John MOTIONED to reappoint Jean S. Hansen (R), to the Commission on Aging – term from August 7, 2021 to August 7, 2023; SECONDED by Selectman Strobel. Unanimous approval.

## **Discussion & Consideration**

#### Bioski Tax Liens

Attorney D'Angelo explained that Mr. Bioski's daughters are proposing to purchase the tax liens on the property at 166 Leonard Road, Middlebury, CT. Mr. Bioski was not aware that three parcels of his land were designated as buildable lots that were overvalued for assessment purposes in 2009 and should have been designated as forestry. Heidi Bioski stated that 30 days would be more than generous for the family to get the \$76,007.00 in past due real estate taxes and associated liens, penalties' and accrued interest outstanding on the above-mentioned property.

First Selectman St. John MOTIONED to accept the proposal of Edward V. Bioski, Jr., to pay the past due real estate taxes and associated liens, penalties' and accrued interest outstanding in the amount of \$76,007.00 within 30 days to the Tax Collector of the Town of Middlebury; SECONDED by Selectman Strobel. Unanimous approval.

Administrative Assistant to the Police Department Job Description

First Selectman St. John MOTIONED to approve the Administrative Assistant to the Police Department job description which removes NEXGEN assignment and other police duties; SECONDED by Selectman Barra. Unanimous approval.

## Administrative Lieutenant Job Description

First Selectman St. John MOTIONED to approve the Administrative Lieutenant job description which now includes the assignment of facilitating the NEXGEN system and other administrative policies duties formally performed by the Administrative Assistant of the Police Department; SECONDED by Selectman Barra. Unanimous approval.

Sgt. Hunt will now be Administrative Lieutenant. This is a change and not an addition in staff to the police department.

Chief Financial Officer Job Description

Selectman Strobel requested to see changes made to the job description. This item was TABLED.

Selectmen's Reports

Out-of-State Motor Vehicle Registration – Selectman Barra, Acting Chief Deely
Selectman Barra is leading the process to draft an ordinance on the issuance of a citation and appeal process for out-of-state motor vehicle registration in Middlebury. The First Selectman stated that many new individuals have moved into the area and this could be part of the reason there are so many out-of-state plates in town. Chris Kelsey has accumulated lists from various service departments and has some idea of who registrants with out-of-town

plates. The First Selectman requested that a draft ordinance be presented for approval by the October 4, 2021 Board of Selectmen's meeting.

## Voice Over IP/IT Updates - Selectman Strobel

Selectman Strobel presented an update of VOIP/IT. She explained that they are still waiting to drop internet in the Town Hall and install three firewalls, access points in Shepardson Community Center, Town Hall and at the Department of Public Works as well as 48 ports of entry switches.

## Purchasing & Bidding Procedure - First Selectman St. John

The First Selectman explained that he made changes to the above-mentioned procedure to increase the amount of a purchase from \$500.00 to \$1,000.00 for a required purchase order and to include approval by the First Selectman for requisitions, the awarding of contracts and purchases.

Human Resources Policies & Procedures Manual – First Selectman St. John First Selectman St. John informed the Board that McInnis, Inc. has begun working on the Town's policy and procedures manual.

At this time the First Selectman read aloud the attached thank you note to Kenneth Heidkamp for his generous contribution of \$15,000 to the Middlebury Police Department for firearms.

#### **Public Comments**

Greg Barnes attended the meeting to get an update on his proposal of making Spring Road a one-way street. The First Selectman said that did not have the opportunity to speak with Mr. Barnes' neighbors regarding his proposal. Mr. Barnes said that what his neighbors feel should not make a difference in making the road one way, if the First Selectman was not going to ask both neighbors, and suggested closing the road for a trial run for two weeks.

There was some discussion on the issues the police department is experiencing with four-wheelers, quads and motorbikes being ridden throughout the town. These illegal vehicles make it dangerous for motorists and the Acting Chief will be working on ordinances to address the issue. The Acting Chief also explained that the traffic issues at Quassy Amusement park are causing traffic backups in the area and on Route 64 and that he would speak with officials at the park regarding these issues. Acting Chief Deely explained that the department made six motor vehicle stops on Watertown Road and they are trying to address Mr. Barnes' speeding concerns.

First Selectman St. John MOTIONED to ADJOURN the meeting at 4:37 p.m., SECONDED by Selectman Strobel. Unanimous approval.
