Chief's Report

- December 15, 2021 I participated in a forum in Watertown to address the spike in Juvenile Crime.
- December 20, 2021 Met with representatives from Ridgewood Condominium Complex regarding emergency access.
 - Concerns are over the single road for residents entering and exiting the complex.
 - Solutions are being discussed.
- Presently working on funding for 3 additional Rekor cameras through private funding.
- Work continues on the Emergency Ops Center (EOC) with Utility Communication completing more electrical work.
 - The EOC will have multiple functions like holding meetings or for training.
- We have applied for a Violent Crime Prevention (VCP) grant offered by the State of CT OPM to the sum of \$20,000.00.
 - The criteria we used to support our request is our participation in the MOU with Waterbury.
 - It is estimated that this grant would fund 41 days of participation during the timeframe (February 1, 2022 – September 30, 2022).
 - We received an email stating that the award package will be mailed over for signature.
- December 31, 2021 The Middlebury PD received a \$5,000.00 donation from a Middlebury Resident.
 - The funds are to be used to upgrade the gym equipment.
 - This is a must as a Police Officer must maintain a certain level of physical fitness to minimize risk of injury and to perform at the high level required to keep Middlebury residents safe.
