- The speed trailer was setup on Spring Road between 10/21/21 through 10/23/21.
  - The average number of cars throughout these dates was 50 cars.
- Applied for the Thomaston Savings Bank Grant for the All-Traffic Solutions Speed Sign.
  - The speed sign can be setup on telephone poles and will be a huge asset on the majority of roads in Middlebury, since it does not take up as much space as the Speed Trailer.
- Discussed with Ron Clark about a Crisis Intervention Team (CIT).
  - We are looking into getting guys certifications to be CIT responders with the potential of having two trainers.
- The LPR company will lease three plate readers for a year
  - We have a possible donation to acquire these, which will add a lot of value to the town.
- 10/31/21 The PBA hosted a Trunk or Treat at Memorial Middle School
- 11/1/21 The demolition in the Dispatch Room began with Utility
  - Phase one of the project is complete and we will contact Utility to begin Phase two
- Middlebury PD assisted Naugatuck PD in the pursuit and apprehension of the two suspects that hit an officer on private duty
  - o Two officers are on the Accident Reconstruction Team
