Chief's Report:

- 1. Officer Randy Guisto located Thomas Barber, who is a Vietnam Veteran, lost in the woods near 266 Kelly Road. Mr. Barber was dressed only in a bathrobe and one slipper. Connecticut State Police responded with a K-9. Officer Terzigni responded with the department drone.
- The Middlebury Police Department hosted the Western Connecticut Coalition Postvention Training at the Middlebury Fire Department on November 29, 2023. This is coinciding with the CIT Training that Sergeant Kalvaitis completed.
- 3. New CAT Generator installed at the Police Department on November 30, 2023. This was for a POSTC Accreditation Standard. This was started by Accreditation Manager Amy Von Vulin.

- 4. Traffic Study on 1428 Straits Turnpike per resident request. The Police Commission discussed this issue and wanted the Chief to request a traffic study in order to address her concerns.
- 5. Officer Erik Markiewicz 12/06/2023 Waterbury Auto Theft Task Force firearms seizure.
- 6. The Middlebury Police Toy Drive was a success. The Department raised \$1913.00 for needy children plus the toy donations. Officer Fred DuVerger deserves much of the credit.
- 7. Accreditation Manager Amy Von Culin had AES install smoke and fire detectors in the cellblock and booking areas. AES also installed microphones in the cell block and booking areas. These areas are now up to the accreditation standard.
- 8. Chief Deely reported the upcoming closure of the South Street Bridge due to repairs. The Chief suggested a detour to Longmeadow Road.
