 - Reviewed body camera footage of the different interactions the officers face while on patrol.
- Contract for 3 Rekor cameras was signed and returned due to a generous donation. The estimated install will be 6 weeks, with Naugatuck and Watertown getting their cameras installed in the same timeframe.
 - Waterbury will soon be on board.
- Ring App allows the people of Middlebury to communicate with Police Officers and fellow neighbors.
 - If you see something, say something.
- Dashcams were installed by Axon on November 16^{th.}
 - o A demonstration of the dashcams was presented to the commissioners.
 - The visual and audio quality is outstanding.
- We are hoping the residents on Burr Hall Rd. can come to a resolution on the parking issues otherwise "No Parking" signage will be installed and enforced.
- The Humvee was returned to Pennsylvania.
- The day room had new cabinets installed.
- We did not receive the Thomaston Savings Foundation Grant.
- Due to the increase in Juvenile Crime, ex.) A Middlebury citizen was assaulted by car thieves, neighboring Police Departments like Naugatuck, Waterbury, and Watertown are regionalizing technology and manpower to tackle the increased crime rate.
- Congratulations to Commissioners Moreira, Bowler, and King on their reappointment.
