<u>Sewer Line Extension – Straits Turnpike</u>

At this time Attorney Yoxall explained that she came before the Board in September for their informal referral preliminary approval of the attached plans after the WPCA approved the capacity applications in connection with the extension. Attorney Yoxall explained that this project will be funded by three adjacent property owners and is located in an area intended to be considered for sewers in the WPCA's 1967 preliminary design report.

Revision to Placement of Obstructions onto Public Roadway Ordinance

Attorney Smith recommended the attached procedural changes to the Ordinance that include finable arrangements. Attorney Smith added that snow or any other type of debris (leaves, grass) can be an obstruction. This debris would have to be intentionally placed in the roadway.
