REGULAR MEETING MINUTES June 26, 2018

## I. CALL TO ORDER

The Meeting was called to order at 7:30 p.m. by Chairman Bowler.

#### II. ACTION ON MINUTES OF MAY 29, 2018 REGULAR MEETING

<u>Motion</u>: to accept the Minutes of the May 29, 2018 Regular Meeting. Made by Keli-Ann Bollard seconded by Greg Bonacorsi. Unanimous Approval.

#### III. OLD BUSINESS

#### 1. APPLICATION #416 – WPCA-PUMP STATIONS 4 & 6

Ken Long spoke on behalf of the Town of Middlebury WPCA and reviewed the plans with the Commission. They are seeking approval to upgrade Pump Station 4 which is on Southford Road and Pump Station 6 which is on Christian Road. Both are within the upland review area.

<u>Pump Station 4</u> - They plan to remove the underground fuel tank which must be removed per DEEP and remove the generator from inside the building to outside of the building and place it on a concrete pad which will be set to the 100 year flood level.

<u>Pump Station 6</u> – The applicant is seeking approval to remove the existing underground fuel tank, generator and electrical equipment. They a proposing to construct a building to house a new concrete slab and generator which would also be utilized to store various pieces of equipment which are currently scattered throughout the town. The elevations will go into the existing drainage and are indicated on the proposed plans.

<u>Motion</u>: to approve Application #416 – WPCA-Pump Stations 4 & 6 per the Draft Resolution. Made by Greg Bonacorsi, seconded by Keli-Ann Bollard. Unanimous Approval.

## 2. PERMIT MODIFICATION #290-C – 393 WHITE DEER ROCK ROAD

Attorney Michael McVerry of 35 Porter Avenue, Naugatuck, CT 06770 spoke on behalf of the applicant Garrett Moore Jr. and Emily Moore and reviewed the plans with the Commission. Once the building was completed and upon the applicant's attempt at obtaining a C.O., it was determined that the walls and walkways are within the setback from the lake and they are now seeking a modification of their prior approval.

<u>Motion</u>: to approve Permit Modification #290-C – 393 White Deer Rock Road per the Draft Resolution. Made by Keli-Ann Bollard, seconded by Greg Bonacorsi.

<u>Amendment</u> to the above motion to include the following as item #2 on the Draft Resolution: (2) The applicant is reminded for any future regulated activities; a permit must be obtained prior to completing the work. Unanimous Approval.

# 3. <u>APPLICATION #410 – TOWN OF MIDDLEBURY-TRANQUILITY ROAD BRIDGE</u>

John Calabrese, P.E. updated the Commission with respect to the emergency repairs that were performed as a result of the collapse under the arch of the Tranquility Road Bridge. The work has been completed and asked if any of the members had any questions.

Chairman Bowler reminded all that this was an emergency situation.

<u>Motion</u>: to approve Application #410 – Town of Middlebury-Tranquility Road Bridge per the Draft Resolution. Made by Keli-Ann Bollard, seconded by Greg Bonacorsi. Unanimous Approval.

#### 4. <u>APPLICATION #411 – 14 WEST LAKE ROAD</u>

Guy Gentil is seeking to rebuild the lakeside wall which has become deteriorated by the water's edge. He reviewed photos of the current condition of the wall with the Commission.

- (2) The applicant shall notify the enforcement officer forty-eight (48) hours prior to the commencement of work and upon its completion.
- (3) Timely implementation and maintenance of sediment and erosion control measures are a condition of this approval. All sediment and erosion control measures must be maintained until all disturbed areas are stabilized.
- (4) No equipment or material including without limitation, fill, construction materials, or debris, shall be deposited, placed or stored in any wetland or watercourse on or off site unless specifically authorized by this approval.

- (5) No equipment or material including without limitation, fill, construction materials, or debris, shall be deposited, placed or stored in any wetland or watercourse on or off site unless specifically authorized by this approval.

- (4) Timely implementation and maintenance of sediment and erosion control measures are a condition of this approval. All sediment and erosion control measures must be maintained until all disturbed areas are stabilized.
- (5) No equipment or material including without limitation, fill, construction materials, or debris, shall be deposited, placed or stored in any wetland or watercourse on or off site unless specifically authorized by this approval.
