Call to Order with Pledge of Allegiance

The meeting was called to order at 3:00 P.M. by Mrs. Smith with the Pledge of Allegiance.

Approval of April 9, 2019 Meeting Minutes – Mrs. Fahey MOTIONED to approve the Minutes of the April 9, 2019 Meeting as submitted, SECONDED by Mr. Desmarais, unanimous approval.

Trustee Reports

Treasurer's Report – Mr. Stowell submitted the Treasurer's Report to each Trustee Member. There was no activity in the Brick Sales and Room Naming Opportunities accounts during the period April 1, 2019 through April 30, 2019. Total Brick Sales to date = \$52,060.00, Total Expenses to date = \$22,449.45, Balance in Fund 61 (Brick Sales and Room Naming Opportunities account) = \$22,610.55.

Mr. Desmarais MOTIONED to approve the Treasurer's Report as submitted, SECONDED by Mr. Clark, unanimous approval.

Secretary's Report – Mr. Desmarais noted correspondence addressed to Mrs. Lo-Russo from ION Bank dated April 29, 2019 regarding a grant request denial (copy attached).

Mr. Clark MOTIONED to approve the Secretary's Report, SECONDED by Mr. Vaccarelli, unanimous approval.

Library Board of Trustees May 14, 2019 Page Two

Director's Report – Mrs. LoRusso confirmed that all Board Members received the attached Director's Report, Statistics for April 2019 and May Library Programs and Services and Upcoming Events. A brief discussion took place regarding the Watertown Art League (WAL) Art Show currently underway. The set up and placement locations of various art pieces throughout the library rather than in the Larkin Room proved to be favored by the public and library staff. The signage and advertising provided by WAL read in part Art Show and "Sale". Mrs. LoRusso noted that as in the past, WAL was made aware in writing (attached) that "no selling of artwork is allowed on library premises". Suggestions were made by Trustee members as to how to address this matter for future similar events.

Mrs. LoRusso referenced CGS Sec. 53-21a in response to last month's discussion regarding "child left unsupervised" in a public place. Under the age of twelve (12) years is noted within said statute.

Mrs. LoRusso also provided fully executed copies of the *Friends* Memorandum of Understanding and Lower Level Storage Area Procedure (attached).

Mr. Stowell MOTIONED to approve the Director's Report, SECONDED by Mrs. Fahey, unanimous approval.

Old Business – Library Policy Manual

An updated manual including prior suggestions / changes was distributed for review. Discussions took place regarding various sections. Mrs. Smith requested this manual be further reviewed and discussed at next month's meeting.

New Business – In a continued effort to show support to the Friends of the Middlebury Public Library, Inc., Mrs. Fahey recently contacted Karen Stowell, President. Upcoming fundraiser events include the monthly book sale which is this Saturday May 18th from 10:00 to 12:00 and the Antiques Appraisals event on May 16th. The Annual Meeting is scheduled for June 10th. New members and volunteers are needed.

Chapter 939 - Offenses Against the Person



Sec. 53-21a. Leaving child unsupervised in place of public accommodation or motor vehicle. Failure to report disappearance of a child. (a) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly leaves such child unsupervised in a place of public accommodation or a motor vehicle for a period of time that presents a substantial risk to the child's health or safety, shall be guilty of a class A misdemeanor.

- (b) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly leaves such child unsupervised in a place of public accommodation, which holds a permit issued under chapter 545 for the sale of alcoholic liquor for consumption on the premises, for a period of time that presents a substantial risk to the child's health or safety, shall be guilty of a class D felony.
- (c) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly leaves such child unsupervised in a place of public accommodation or a motor vehicle between the hours of eight o'clock p.m. and six o'clock a.m. for a period of time that presents a substantial risk to the child's health or safety, shall be guilty of a class C felony.
- (d) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly fails to report the disappearance of such child to an appropriate law enforcement agency shall be guilty of a class A misdemeanor. For the purposes of this subsection, "disappearance of such child" means that the parent, guardian or person does not know the location of the child and has not had contact with the child for a twenty-four-hour period.

Chapter 939 - Offenses Against the Person

Sec. 53-21a. Leaving child unsupervised in place of public accommodation or motor vehicle. Failure to report disappearance of a child. (a) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly leaves such child unsupervised in a place of public accommodation or a motor vehicle for a period of time that presents a substantial risk to the child's health or safety, shall be guilty of a class A misdemeanor.

- (b) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly leaves such child unsupervised in a place of public accommodation, which holds a permit issued under chapter 545 for the sale of alcoholic liquor for consumption on the premises, for a period of time that presents a substantial risk to the child's health or safety, shall be guilty of a class D felony.
- (c) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly leaves such child unsupervised in a place of public accommodation or a motor vehicle between the hours of eight o'clock p.m. and six o'clock a.m. for a period of time that presents a substantial risk to the child's health or safety, shall be guilty of a class C felony.
- (d) Any parent, guardian or person having custody or control, or providing supervision, of any child under the age of twelve years who knowingly fails to report the disappearance of such child to an appropriate law enforcement agency shall be guilty of a class A misdemeanor. For the purposes of this subsection, "disappearance of such child" means that the parent, guardian or person does not know the location of the child and has not had contact with the child for a twenty-four-hour period.

Memorandum of Understanding

The Friends of the Middlebury Public Library, Inc. and the Middlebury Public Library

The following will constitute an operating agreement between the Friends of the Middlebury Public Library, Inc. and the Middlebury Public Library. It will stand until and unless it is modified by mutual agreement of the Friends executive board and the Middlebury Public Library. The Friends mission is to raise money and public awareness in the community to support the services and programs of the Library. As a non-profit, 501(c)(3) organization, however, it is a legally distinct entity and is not a part of the library.

The Library agrees to inform the Friends of the goals and direction of the Library for future funding.

The Library agrees to provide public space for Friends membership brochures and promotional materials.

The Library agrees to provide the Friends with the designated space in the lower level of the Library for book storage, sorting, and office needs under the adopted guidelines dated January 13, 2015.

The Friends agree to publicly support the library and its policies.

The Friends agree to include the library's liaison at all Friends' meetings.

The Friends agree that any monies raised will be spent exclusively for library programs, services, and other library defined needs per the Library Director. Disclosure of assets will be provided when requested by the Library's Board of Trustees.

The Friends agree that the Library Director has the final say in accepting or declining any and all gifts made to the library.

The Friends agree to engage in advocacy efforts on behalf of the library under the guidance of the Library's Board of Trustees.

The Friends agree to provide a current copy of the Friends Bylaws.

The Friends agree that if they cease to actively fundraise and promote the library, they will disband, allowing for a new Friends group to be established in the future.

Dear Friends of the Middlebury Public Library, Inc.:

The following procedures have been adopted by the Library Board of Trustees to secure safety and comfort, while maintaining efficient operation of the Library's Lower Storage Area facility and consideration to all involved.

Adherence to these procedures is mandatory. Any violation will result in loss of the use of the above mentioned facility.

- 1) All entryways and exits should be kept free of obstructions at all times.
- 2) All books and other materials should be kept off of the floor at all times. Exceptions may be granted as needed and require prior written authorization from the Library Director.
- 3) Movement of library equipment or furnishings require prior written authorization from the Library Director.
- 4) Users of the facility will be responsible for all trash removal after each use.
- 5) There is only 1 access key, located at the information desk, to be given to the Friends of Middlebury Public Library, Inc., and under no circumstances shall this key be duplicated or be removed from the premises.
- 6) Lower level access is only available during library hours. Exceptions may be granted as needed and require prior written authorization from the Library Director.
