1. <u>Straits Crossing, LLC/Corner of Park Rd. & Straits Turnpike – Application for</u> Zoning Map Amendment LI-80 to CA-40 (Application #2019-7-2)

Chairman Smith read the legal notice published in Voices on 7-17-19 & 7-24-19 for the record.

Attorney James Strub of Secor, Cassidy & McPartland, P. C. in Waterbury, CT spoke on behalf of the applicant. For the record, he submitted a copy of the notice that was sent to all abutting property owners within 500 feet of the subject property as well as a copy of the certificate of mailings. The zone line bisects the property and creates a smaller portion zoned CA-40 and then a larger piece which is zoned LI-80. Based on the development of the four corners, the applicant feels it is only logical to switch the entire property to CA-40. The buildable area happens to be the dry area that would be bisected by the zone line. Relative to the wetlands, stonewalls and otherwise, they met with Dr. Peterson on behalf of the Middlebury Land Trust and will continue to work together in the hopes of accommodating all and to leave the boundary stonewalls in place.

Chairman Smith stated that they must continue the Public Hearing to allow for the 35 day requirement.
