Chief's Report

The Chief explained that they are over budget in fuel, office supplies and in traffic signs line items.

Officer Olivera is on the swing shift; until the bidding on the schedules comes up. The Chief has Officer Olivera as a back up to Officer Pruchnicki.

The Impala needs \$500 in repairs. The Town Mechanic feels that the car is worth repairing. There are 16 mandated policies that need to be updated. Officer Dabbo will review these with officials at Post. The new AFIS machine is installed; the technician will be in to make a software update.

The Chairman requested that the next Police Commission meeting take place at the Police Department. The Chief would like to give commendations to officers at the next meeting to recognize their efforts in January 22, 2019 incident at MES.

The Chairman inquired about the status of issues with Northwest. The Chief said that things were progressing; there are some data issues which may be rectified with NEXGEN. Chris Medeiros provides assistance where he can. The meetings are combined with Waterbury Police Department.

The Chairman inquired about NEXGEN being used in the vehicles; this has been completed. Commissioner King inquired about the body cameras; Chief Dabbo said that there are some officers that continue to not use the cameras and he will work to retrain these officers.

Attorney Smith said that the scheduled doubles decision was ruled in favor of the Town of Middlebury.

There was some discussion on pending grievances. .Commissioner King inquired about radar; it is being run in Town.
