Chairman Moreira received a Departmental Award request for Officer George Slaiby with recommendation from Sgt. Pat Deely. Chief Dabbo provided insight to Officer Slaiby's life saving act on a Middlebury Resident.

Chairman Moreira read a thank you note received from the Celebrate Middlebury Committee for the police department's participation in the Celebrate Middlebury event.

Chief's Report

Chief Dabbo commended the officers on 269 motor vehicle stops during the month of September. The new license plate reader is extremely helpful in monitoring vehicles traveling throughout Middlebury. Commissioner Bowler stated he has noticed an increase in police presence and believes that presence is a deterrent for criminal activity.

Reserve Officer Baskins resigned from his position with the department, citing a busy schedule. The department currently has three reserve officers. The Department is in the process of hiring a new full time officer from out of state. They are waiting on a comparative analysis with POSTC to determine what needs, if any, should be completed for Connecticut guidelines.
