A performance bond must be posted in an amount satisfactory to the Board of Selectmen with a bonding company licensed to do business in the State of Connecticut as surety conditioned on the carrying out of the conditions listed in <u>Section 51.6 of the Town of Middlebury Planning and Zoning Regulations</u> and any other safeguards imposed, and providing that in case of default, the surety shall promptly take any and all steps necessary to comply with said conditions. The bond furnished hereunder shall contain a provision that the surety will not release said bond until all the work called for therein is performed.

Please complete the attached form and return it with one of the acceptable forms of written guaranty from your bank to the Town of Middlebury. The Town of Middlebury requests this guaranty in case of failure of performance.

This bond amount is recommended by the Town Engineer or Wetlands Officer and approved by the Board of Selectmen. Please contact John Calabrese at 203-598-4390 to begin this process.

By signing the application, you agree to reimburse the Town of Middlebury for expenses and damages caused by the work execution, and to perform the working according to the regulations for permit work as stipulated by the Town of Middlebury. The owner of the property for whom this work is being performed agrees to accept all future maintenance responsibility for the work as described herein.

PERFORMANCE BONDS*

Issued by Surety authorized to conduct business in Connecticut. The bond MUST describe the improvements that will be completed. The bond MUST be in effect until released by the Board of Selectmen.

IRREVOCABLE LETTER OF CREDIT*

Irrevocable Letters of Credit must issued by a bank authorized to conduct business in Connecicut describe the work or improvements that will be completed. The Letter of Credit will (that automatically renews) be in effect until it is released by the Board of Selectmen.

DUAL PASSBOOK SAVINGS ACCOUNT*

Dual Passbook Savings Account must be issued by a banking institution authorzed conduct business in Connecticut. The passbook must be in the name of the Developer or Applicant AND the Town of Middlebury for the bond amount set by the Board of Selectmen. The Developer's federal identification number should be used to open up the account.
